

## **The "Wondaland Revue Coming To A City Near You Sweepstakes" Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

The "Wondaland Revue Coming To A City Near You" Sweepstakes (the "Sweepstakes") may only be entered in or from the fifty (50) United States and the District of Columbia (excluding its territories and possessions) (collectively, the "Sweepstakes Territory"). Entries originating from any other jurisdiction are not eligible. You are not authorized to participate in the Sweepstakes if you are not located within the Sweepstakes Territory.

### **1. Eligibility.**

Participation in the **Sweepstakes** is open only to legal residents of the Sweepstakes Territory who are eighteen (18) years of age or older as of June 28, 2015. Void outside of the Sweepstakes Territory and where prohibited, including, but not limited to, where taxed or restricted by law. Employees, officers and directors of Sony Music Entertainment ("Sponsor"), and its parent company, subsidiaries, affiliates, partners, dealers, advertising and promotion agencies, manufacturers or distributors of Sweepstakes materials (the "Sweepstakes Entities") and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such employees, officers and directors are not eligible to enter.

### **2. How to Enter.**

The Sweepstakes will begin on June 28, 2015 at 8:00 p.m. ET and will end on July 28, 2015 at 4:00 p.m. ET ("Sweepstakes Period"). There are two (2) methods to enter the Sweepstakes (each, an "Entry", collectively, "Entries"). You may either: (i) by navigating to [Shazam.Wondaland.com](http://Shazam.Wondaland.com) during the Sweepstakes Period, and filling out the entry form with the required information, including your full name, email address and preferred tour date ("Tour Date") in the drop down menu; or (ii) using the Shazam™ music application (the "App") installed on your mobile device to tag any song by Wondaland during the Sweepstakes Period and fill out the entry form you are brought to at [Shazam.Wondaland.com](http://Shazam.Wondaland.com) with the required information, including your full name, email address and preferred Tour Date in the drop down menu (if you do not already have the App installed, visit <http://www.shazam.com> and follow the instructions to set up the App on your mobile device). All eligible Entries will be entered into a series of random drawings for a chance to win two (2) concert tickets for the Tour Date noted in their Entry.

ONE ENTRY PER PERSON. If multiple Entries are received by the same entrant, only the first Entry submitted by that entrant will qualify as Entry into the Sweepstakes; subsequent Entries submitted by that entrant shall be disqualified. No automated entry devices and/or programs permitted. Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted, or garbled Entries, which will be disqualified. Only fully completed entry forms are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor.

### **3. Prize.**

Eight (8) Grand Prize Winners (the "Winner(s)"), one (1) for each Tour Date set out on the entry form, will each receive two (2) concert tickets to the Tour Date noted in their Entry, scheduled to take place in July and August 2015 (collectively, the "Prize").

**Entrants acknowledge that the Prize does NOT include travel and transportation to and from the concerts locations, venues, and cities. Only two (2) tickets per Tour Date will be awarded.**

Tickets are not for sale, the Prize has no perceived retail value. The determination that the Prize has no perceived retail value represents Sponsor's good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the Prize turns out to be less than the stated approximate retail value, the difference will not be awarded in cash. Prize is non-transferable. No substitutions or cash redemptions. Sponsor reserves the right to substitute the Prize in whole or in part for a prize of equal or greater value in the event that any component of the Prize is unavailable for any reason. Prize may not be sold, bartered or transferred. Prize does not include any additional expenses, including, but not limited to incidentals, meals, telephone charges, travel insurance, souvenirs, transportation, federal, state and local sales or other taxes and surcharges which are the responsibility of each Winner.

Winners and their guests must be at least eighteen (18) years old as of June 28, 2015. If any Winner or guest is under the age of majority in the state in which he or she resides as of June 28, 2015, such individual must obtain express written permission to accept the Prize or accompany the Winner from his or her parent or legal guardian. The Winner and his or her accompanying guest will be required to sign and return an Affidavit of Eligibility and Liability/Publicity Release within two (2) calendar days of Prize notification. If any Winner or accompanying guest is under the age of majority in the state in which he or she resides as of June 28, 2015, the Affidavit of Eligibility and Liability/Publicity Release must be signed and submitted by their parent or legal guardian. If any Winner rejects his/her Prize or in the event of noncompliance with these Sweepstakes rules and requirements, such Prize will be forfeited and an alternate Winner may be selected from all remaining eligible Entries. Upon Prize forfeiture, no compensation will be given. Sponsor does not accept any responsibility for the delivery of the Prize and/or the mail service.

#### **4. Random Drawing/Odds.**

The Winners will be selected in a series of random drawings from all eligible Entries received and based on the Tour Date noted in such Entries, beginning on or about July 28, 2015, and no later than four (4) days prior to each Tour Date. Odds of winning depend on the number of eligible Entries received. The drawing will take place at the Sponsor's offices of Epic Records, 550 Madison Avenue, New York, New York 10022. Winners will be notified via email. If a Winner cannot be contacted within one (1) calendar day of first notification attempt, the Prize will be forfeited and an alternate Winner may be selected from all remaining eligible Entries. By entering the Sweepstakes, entrants fully and unconditionally agree to be bound by these rules, which will be final and binding in all matters relating to the Sweepstakes.

#### **5. Conditions.**

All federal, state, provincial and local taxes are the sole responsibility of the Winners. Participation in this Sweepstakes and acceptance of Prize constitutes each Winner's permission for Sponsor to use his/her name, address (city and state), likeness, photograph, picture, portrait, voice, biographical information and/or any statements made by the Winners regarding the Sweepstakes or Sponsor for advertising and promotional purposes without notice or additional compensation, except where prohibited by law. By participating, entrants and Winners agree to release and hold

harmless Sponsor, Sweepstakes Entities, Facebook, Instagram and their respective parent companies, subsidiaries, affiliates, partners, representatives, agents, successors, assigns, employees, officers and directors ("Released Parties") from any and all liability for loss, harm, damage, injury, cost or expense whatsoever including, without limitation, property damage, personal injury and/or death which may occur in connection with, preparation for, travel to, or participation in Sweepstakes, or possession, acceptance and/or use or misuse of Prize or participation in any Sweepstakes-related activity and for any claims based on publicity rights, defamation or invasion of privacy and merchandise delivery. Released Parties are not responsible if the Sweepstakes cannot take place or if any Prize cannot be awarded for any reason, including, but not limited to, due to travel cancellations, delays or interruptions due to acts of God, acts of war, natural disasters, weather, or acts of terrorism. There is no purchase or sales presentation required to participate. A purchase does not increase odds of winning.

## **6. Additional Terms.**

In the case of a dispute as to the identity of any entrant, the Entry will be deemed to have been submitted by the authorized holder of the email account associated with the winning Entry. "Authorized Account Holder" is defined as the natural person to whom an email account is assigned. Any potential Winner may be requested to provide Sponsor with proof that such Winner is the authorized account holder of the email account associated with the winning Entry. Any other attempted form of Entry is prohibited; no automatic, programmed, robotic, or similar means of entry are permitted. Released Parties are not responsible for technical, hardware, software, telephone, or other communications malfunctions, errors or failures of any kind, lost or unavailable network connections, web site, Internet, or ISP availability, unauthorized human intervention, traffic congestion, incomplete or inaccurate capture of Entry information (regardless of cause), or failed, incomplete, garbled, jumbled, or delayed computer transmissions that may limit one's ability to enter the Sweepstakes, including any injury or damage to participant's or any other person's computer relating to or resulting from participating in this Sweepstakes or downloading any materials in this Sweepstakes. Sponsor reserves the right to cancel, terminate, modify, extend or suspend this Sweepstakes should it determine, in its sole discretion, that a virus, bug, non-authorized human intervention, fraud, or other causes beyond its control corrupt or affect the administration, security, fairness, or proper conduct of the Sweepstakes. In such case, Sponsor will select the Winner(s) from all eligible Entries received prior to and/or after (if appropriate) the action taken by Sponsor. Sponsor reserves the right to disqualify any individual it finds, in its sole discretion, to be tampering with the entry process or the operation of the Sweepstakes or website. Sponsor may prohibit an entrant from participating in the Sweepstakes or winning a Prize if, in its sole discretion, it determines that said entrant is attempting to undermine the legitimate operation of the Sweepstakes by cheating, hacking, deception, or other unfair playing practices (including the use of automated quick entry programs) or intending to annoy, abuse, threaten, or harass any other entrants or Sponsor's representatives. Sponsor reserves the right not to award any or all Prize, or to cancel, terminate, modify, extend, or suspend this Sweepstakes without liability in the event an insufficient number of eligible Entries are received.

## **8. Issues of Law.**

All federal, state, and local laws and regulations are applicable. THE NEW YORK COURTS (STATE AND FEDERAL) SHALL HAVE SOLE JURISDICTION OF ANY CONTROVERSIES REGARDING THIS SWEEPSTAKES AND THE LAWS OF THE STATE OF NEW YORK SHALL EXCLUSIVELY GOVERN THIS SWEEPSTAKES WITHOUT REGARDS TO CONFLICT OF LAW RULES. EACH ENTRANT EXPRESSLY WAIVES THE RIGHT TO HAVE ANY SUCH ACTION OR PROCEEDING HEARD BEFORE A JURY.
